Intreoir: Cad chuige a bhfuil Acht na Gaeilge de dhíth?

Tá an iliomad fáth ann d'Acht. Cé acu a dhéanann muid tagairt de ról stairiúil na Gaeilge; den fhéinchumhachtú a bhaineann leis an Ghaeilge a fhoghlaim; den tábhacht cultúrtha roinnte atá léi; de na gealltanais a rinneadh i gcomhaontú Aoine an Chéasta agus comhaontú Chill Rímhinn; nó de na cairteacha Eorpacha agus idirnáisiúnta a dhearbhaíonn na réimsí leithne d'fhreagrachtaí reachtúla atá ar rialtais chun mionteangacha a chosaint; leo féin is cúis go leor gach ceann de na fáthanna sin chun Acht na Gaeilge a chur i bhfeidhm.

Ach níl tagairt ann ansin don chúis is bunasaí, dóshéanta le hacht a chur i gcrích. Sin é, go bhfuil ann do phobal na Gaeilge ó thuaidh. Is pobal iad a labhraíonn an Ghaeilge, a thugann tacaíocht nach beag di, a fhoghlaimíonn faoin domhan inti, agus pobal a bhfuil fás milteannach tagtha uirthi le blianta beaga anuas (meastar i gceann seacht bliana go mbeidh dúbláil ar an 6,000 duine a fhreastalaíonn ar an chóras oideachais trí mheán na Gaeilge ó thuaidh). Agus faoi láthair níl aon chosaint ón stát ann don phobal seo ar nós atá ann do chainteoirí Breatnaise sa Bhreatain Bheag. Mar sin de tá sé de chumhacht ag an stát leatrom nó neamhaird a léiriú ar phobal na Gaeilge, agus gan aon meicníocht dlíthiúil ann le dul i ngleic leis sin. Sampla soiléir a bhí i gcás Líofa ar na mallaibh, ach ba shampla beag é de phatrún leanúnach fadtréimhseach.

Faoi láthair tá todhchaí phobal na Gaeilge, agus todhchaí na teanga í féin, ag brath go hiomlán ar dhearcadh phearsanta feidhmeannaigh agus airí. Tá géarghá le hAcht na Gaeilge le cosaint reachtúil, dlíthiúil a thabhairt don teanga is dá pobal, agus leis an teanga í féin a shlánú agus a neartú, rud a bheadh ar leas an phobal ar fad i gcoitinne.

Tá deis ar leith againn sa tréimhse stairiúil seo. Don chéad uair riamh, i ndiaidh an toghcháin is déanaí, tá tromlach de na comhaltaí sa Tionól Reachtach i bhfách le hAcht na Gaeilge. Ní mór dúinn an deis sin a thapú, beart a chur le briathar, agus Acht na Gaeilge a chur i bhfeidhm.

Introduction: Why is an Irish Language Act needed?

There are many reasons for an Act. Whether we refer to the historical role of Irish or to the self-empowerment that comes with learning Irish or to the importance of its shared heritage, or to the promises made in the Good Friday Agreement and the St. Andrew's Agreement or to the European and International charters that affirm the wide range of statutory responsibilities incumbent on the Government to defend minority languages, they are reasons within themselves to implement an Irish Language Act.

This, however, does not make reference to the simplest and undeniable reason to implement an act. That is, that an Irish Language community exists in the North. They are a community that speak Irish, that fully support Irish, that learn about the world through Irish, and it is a community that has had a monumental growth in the last few years (it is estimated that the 6,000 people who use the Irish education system in the North will double in the next 7 years).

At present, this community has no protection in the same way as Welsh speakers in Wales do. Therefore, the state has the power to ignore the Irish Language Community or to oppress it, and no legal mechanism exists to address this. The case of *Líofa* recently highlighted this, and was a further example of a continuous, long-term pattern.

Currently the future of the Irish Speaking Community, and the future of the language itself, depends completely on the personal opinions of executives and ministers. There is a desperate need for an Irish Language Act to provide statutory, lawful protection for the language and its community, and to secure and strengthen the language itself, something that would be beneficial to the community in general.

We have a unique chance in this historic period. For the first time ever, after the recent election, a majority of members in the Assembly are in favour of an Irish Language Act. We must seize this opportunity, act on our words, and implement an Irish Language Act.

Cad é atá sa cháipéis seo?

Is pléchaipéis oibre é seo ar Acht Gaeilge. Ní píosa reachtaíochta é ach briseadh síos ar na rannóga difriúla a bheadh bainte le hacht teanga, le míniúchán ar na rannóga sin, agus moltaí practiciúla inoibrithe chun iad a chur i bhfeidhm. Tá sé i gceist ag an cháipéis seo daoine a chur ar an eolas faoi cad is ann d'acht Gaeilge, cad chuige a bhfuil forálacha ar leith de dhíth, agus na dóigheanna is fearr chun na forálacha sin a chur i bhfeidhm. Beidh leasuithe déanta ar an bpléchaipéis oibre de réir is a thagann moltaí agus eolas breise chun cinn.

Nuair is cuí tá briseadh síos ann ar na costais leis na rannóga éagsúla, agus rud atá fíorthábhachtach, tá moltaí ann ar an dóigh na costais seo a choinneáil chomh íseal agus ar féidir. Mínítear gurb é costas aon uaire é go leor den chostas a bhaineann leis an Acht seo a chur i bhfeidhm. In aon teach, a oiread insliú a chuireann tú isteach ag an tús, agus is éifeachtaí a chuirtear isteach é, is lú airgid a bhíonn ort a chaitheamh bliain i ndiaidh bliana ag iarraidh an teach a choinneáil te. Is 'insliú' é Acht teanga do phobal na Gaeilge. Insliú a chosnaíonn an pobal sin roimh ionsaithe agus neamhaird. Mar sin de, is éifeachtaí a chuirtear na rannóga éagsúla i bhfeidhm is i bhfad Éireann níos mó airgid agus oibre a shábháiltear sa mheántéarma agus san fhadtéarma.

Ar ndóigh, beidh costas éigin ann. Ach léirítear go soiléir sa chaipéis seo gur costas fíor-réasúnta é, go háirithe má chuirtear an tAcht i bhfeidhm i gceart agus le dea-thoil.

What is in this document?

This is a discussion piece on an Irish Language Act. It's not a piece of legislation but a break-down of the different sections that would be involved in a language act, with an explanation of these sections, and particular proposals that are workable to implement them. It is the purpose of this document to inform people on what is involved with an Irish Language Act, why provisions to the act are needed, and the best ways to implement said provisions. Changes will be made to the working discussion piece as new proposals and information come to light.

When relevant a breakdown of the costs to the various departments has been provided, and there are important recommendations as to how to keep this cost as low as possible. It is explained that a significant amount of the costs required to implement this Act are one-off costs. In a home, the amount of insulation you initially install, and how effectively it is installed, the less it costs year after year trying to keep the house warm. The Language Act is 'Insulation' for the Irish Language community. Insulation that protects that community from attacks and neglect. Therefore, the more effective these departments are implemented, the more money and work are saved in the medium-term and in the long-term.

There will be some expense, of course. This document highlights, however, that it is a very reasonable cost, especially if the Act is implemented properly and willingly.

Achoimre Fheidhmeach

Moltar thíos go mbeadh 11 rannóg mar chuid d'aon acht Gaeilge. Ina measc tá forálacha a bhaineann le Stadás Oifigiúil na Teanga; An Ghaeilge sa Tionóil, sa Rialtas Áitiúil, agus i gComhlachtaí Poiblí; an Ghaeilge agus an BBC; An Ghaeilge san earnáil Oideachais; Coimisinéir Teanga; agus Logainmneacha.

Is é £9m an costas aon uaire, tosaithe a bheadh le hAcht Gaeilge, thar tréimhse 5 bliana. Bheadh seo caite ar na forálacha cuí taobh istigh de thréimhse ama, seachas ciall díreach ag an tús (meánmhéid de c.£1.8m sa bhliain).

Is é £2m an costas bliantúil a bheadh le hAcht Gaeilge, agus tuiscint ann gur féidir an costas sin a choinneáil réasúnta, inoibrithe má chuirtear an tAcht i bhfeidhm i gceart agus le dea thoil. Is ionann seo agus caiteachas de £10m mar sin thar tréimhse 5 bliana.

Meastar chomh maith go mbeadh £8m sa bhreis d'ioncam don gheilleagar ó thuaidh go bliantúil nuair a chomhlíonfar dualgais an BBC do chraolacháin Gaeilge. Is ionann seo agus ioncam de £40m mar sin thar tréimhse 5 bliana.

Sampla amháin de na moltaí praiticiúla, inoibrithe, chun foráil a chuir i bhfeidhm ar bheaghostas is é an moladh i dtaca le stáiseanóireacht dátheangach de chuid na ranna rialtais. Moltar go ndéantar uasdátú ar an stáiseanóireacht nuair atá an an stoc reatha rite – mar sin de níl costas breise leis, is gnáthchostas ordú stáiseanóireachta atá i gceist, sa chás seo le stáiseanóireacht uasdátaithe. Tá an caipéis seo lán den chinéal seo moladh.

Beidh costas éigin le hAcht Gaeilge a chur i bhfeidhm. Ach an rud a léirítear arís is arís eile sa cháipéis seo nach costas dódhéanta, thar fóir a bheadh i gceist – líomhaint a chuirtear chun tosaigh go minic gan na fíricí é a chosaint. A mhalairt atá fíor, is costas réasúnta, inoibrithe a bheadh ann. Níos tábhachtaí arís, is infheistiú a bheadh ann i bpobail an Tuaiscirt i gcoitinne.

Executive Summary

It is suggested that there would be 11 sections as part of the Irish Language Act. Included in this are provisions which concern the Official status of the language; Irish in the Assembly, in Local Government, and in Public Companies; Irish and the BBC; Irish in the Department of Education; a Language Commissioner; and Place-Names.

£9m is the one off cost, The Irish Language Act would be started over a five-year period. This would be spent on the appropriate demands within that period of time, as opposed to directly at the beginning. An average of £1.8m a year.

The annual cost of the Irish Language Act would be £2m, with an understanding that this cost could be kept reasonable and workable if the Act was put in place properly with good will. This would add up to £10m of expenditure over a five-year period.

It is estimated also that there would be an additional £8m extra spending yearly in the economy in the north when the BBC fulfils its obligations to Irish language programming. This would add up to £40 of extra income over a five-year period.

One example of the practical workable suggestions to implement provisions at low cost regards bilingual stationary in government departments. It is suggested that stationary should be updated when the current stock has run out- therefore this incurs no extra cost, and the cost would be the normal cost of ordering updated stationary. This document contains a considerable number of suggestions like this.

There will be some cost involved in implementing an Irish Language Act. What is shown again and again in this document is that it is not an unfeasible and unreasonable cost that would be involved- an allegation which is often made without the facts to back it up. Contrary to this, it is a reasonable cost, and a cost that would be practical. More importantly, it would represent an investment in the people of the North in general.

SO, WHAT WOULD AN IRISH LANGUAGE ACT INVOLVE?

Here's a simple breakdown of some of the key elements of the Conradh na Gaeilge discussion document, and why they're important.

1

OFFICIAL STATUS

Recognising the Irish Language as one of the official languages of the North, alongside English.
A simple but important measure that would protect the minority rights of Irish speakers.

2

SERVICES

Enabling public bodies to provide a certain baseline level of interaction with the Irish Language community through Irish.
Prioritising those bodies that have a higher level of interaction with the public, and requiring commitments such as having forms and websites in Irish.

3

COST: UNDER £4M A YEAR

This discussion document explains how a language act wouldn't break the bank, how the cost goes **down** as time goes on, and how it is actually an investment in the North as a whole.

4

WORKABLE SOLUTIONS

The discussion document details a host of practical, workable solutions to implementing an effective and reasonably costed Irish Language Act.
International best practice has been taken on board, as well as the successful aspects of legislation in Wales, Scotland and the Republic.

5

PLACENAMES AND SIGNAGE

Visibility of the language is key for its growth, and to demonstrate that it's part of our shared heritage.
To achieve this an act would legislate for bilingual road signage (different from street signs) and official recognition for place names in Irish. The document outlines methods to introduce these measures in as cost-effective a manner as possible.

OTHER PROVISIONS

The act should provide legislative protections for Irish Medium education; create one Central Translation Unit to support public bodies to implement various provisions; increase BBC investment in media in the North; create the Office of the Language Commissioner to act as an oversight.

Appendix 1: Classification of Public Bodies

The intention is to make the implementation of this act as practical and workable as possible, prioritising the way in which the public normally deals with state organisations and using that as a guide in the implementations of the act.

With this in mind, all public bodies in the north should be classified according to three different categories: A, B and C. Classification would be carried out by the Language Commissioner based on an audit of each public body's obligations and on the amount of communication they have with the public, the location of their offices, expected demand for services locally and any other relevant factors. The Language Commissioner would make recommendations in regard to the obligations in each category, including those mentioned above, such as stationery, recruitment policy etc. This particular approach attempts to encompass the lessons learned from the problems faced in the south in respect to language schemes in that it recognises the differences between the various bodies: obligations would be based on the type of interaction each one has with the public.

Category C – Basic Level: Public bodies with very little direct dealings with the public. Such organisations would have basic level obligations, with generous deadlines for fulfilling them.

Example: Rivers Agency

Category B: Public bodies that deal directly with the public quite often, but that also perform certain aspects of their work internally. They would have other duties in addition to those for Category C public bodies, with shorter deadlines too.

Example: Northern Ireland Water

Category A: Public bodies who deal directly with the public on a daily basis: organisations whose services Irish speakers are most likely to want to use. Duties for public bodies in this category would include those in Categories B and C. Any public bodies included in this category would be those that are most important in terms of interaction with the public. It would be expected that they would make sincere efforts to use Irish.

Example: Department of Education

4. B'é c.€566,000 caiteachas na hoifige ó dheas in 2014, agus b'é c.€677,000 caiteachas na hoifige i 2015. Téann thart ar 70% den airgead sin ar thuarastal na foirne, foireann de cheathrar agus uilig ar thuarastal de níos mó ná €60,000 sa bhliain (an CT féin ar €120,000 sa bhliain). Bheadh gá socrú a dhéanamh ar an pá scála a bheadh i gceist ó thuaidh. Fosta, bheadh ceachtanna foghlamtha san Acht seo (Scéimeanna Teanga imithe agus athstruchtúró déanta ar na dualgais sin m.sh), agus mar gheall ar an struchtúr difriúil air i gcomparáid leis an deisceart, tá ag dúil go laghdódh an 'réamhghníomhachas' sa phlean thuas obair/costais na hoifige. Fosta, tá níos lú comhlachtaí poiblí ann ó thuaidh, agus ní bheadh dualgas ag an CT (ag an phointe seo) súil a choinneáil ar a leithéidí Ollscoil Uladh msh. Sin uilig san áireamh, tá £300,000 - £400,000 réasúnta.

Appendix 2: Notes about Costs

5. Costs for Websites: There are approximately 210,000 words on the Department of Communities website, which is among the biggest of all government websites. This cost for translation would be one-off cost of around £23,000 (based on a rate of 11p per word). There are 80,000 words on the CVSNI website. This figure pertains to fixed content and does not include uploaded publications. A cursory glance at all public bodies (approximately 100 in number) shows that 50 of them, at most, have a website. Considering the range of word counts involved, a reasonable estimate for one-off translation costs is £750,000-£1,000,000. This figure is reached using the following computation: 100,000 (average number of words) * 50 * 0.11 = £550,000 (plus an extra amount added to ensure all costs are fully covered.)
6. The total costs for Irish language interpretation by the courts service in the south in 2006 was €2,000; the costs for 2007 were €1,012. In these two years, Irish was not among the ten most used languages in the courts in the south. One would expect the demand for this type of service in the north would be lower than in the south. The cost estimated is £10,000. The fact that some judges in the south have Irish has been taken into account, as has the possibility there wouldn't be the same number of Irish speaking judges in the north. (Having said this, according to the Language Commissioner in the south, the costs saved in the south by having an Irish speaking judge is negligible since the percentage of relevant cases is very small).
7. Signs for public bodies: There are 100 public bodies. The average cost for signage in the south is around €2,200. Unpredictable extra costs are factored into the above figure.
8. The expenditure for the office in the south in 2014 was around €566,000, with the 2015 cost coming to around €677,000. Approximately 70% of this money is spent on staff salaries: a team of four on salaries of more than €60,000 per annum (the Language Commissioner earns €120,000 per annum). A decision would need to be taken about the payscale for the north. Lessons would also have been learned in respect to this act from the experiences in the south (for example, there would be no language schemes and obligations would be restructured). Additionally, due to the different structure being different to that in the south, it is expected the preparatory action taken according to the above plan would help reduce the amount of work and office costs involved. There are also less public bodies in the north, and the duties of the Language Commissioner (at this point) would not include monitoring organisations such as Ulster University. Taking all these factors into account, £300,000 - £400,000 is a reasonable estimate.

Aguisín 3: Comhthéacs Stairiúil

Tá an Ghaeilge á labhairt le breis agus 2,000 bliain agus tá sí ar an teanga scríofa Eorpach is arsa atá go fóill in úsáid sa lá atá inniu ann. Tá rian doshéanta fágtha ag an oidhreacht ríluachmhar ar ár dtírdhreach, ár gcultúr, agus ár muintir. Go deimhin, bhí an Ghaeilge mar phríomh-theanga labhartha ag an tromlach giota agus 150 bliain ó shin. Is scéal é nach n-insítear go minic gurbh Ghaeilgeoirí iad an tromlach a fuair bás nó a chuaigh ar eisimirce mar chuid den Ocras Mór.

Nuair a cháintear polaitiú na teanga, tá neamhaird nó easpa tuisceana á léiriú, nó is ceist pholaitiúil í an Ghaeilge. Ní de thaisme a bhfuil athbheochán le déanamh ar an teanga – is dá bharr polasaithe diúltacha ionsaitheacha in éadan na teanga, thar na céadta, a tháinig an titim suntasach ar líon na gcainteoirí. Bheadh an cur i bhfeidhm ar Acht Teanga ina gníomh dearfach ó thaobh dul i ngleic leis na lochtanna is laigí stairiúla sin.

Is i gComhaontú Aoine an Chéasta a rinneadh na chéad choimitmintí dearfacha i leith na teanga. Cinntíodh i gComhaontú Chill Rìmhinn go ndéanfaidh Westminster acht teanga a rith, ar nós na reachtaíochta agus na straitéisí in Eirinn agus sa Bhreatain Bheag.

Gan aon chosaint dhlíthiúil, níl na comhchearta céanna ag lucht labhartha na Gaeilge agus atá ag cainteoirí Breatnaise, Gaeilge na hAlban nó ag Gaeilgeoirí eile ar na hoileáin seo. Ag tagairt don cheart agus don deis atá agat do theanga dúchais 'a fhoghlaim agus a úsáid', luann an saineolaí teanga Fernand de Varennes gur 'bunchearta iad agus nach féidir iad a chlárú mar dheonú speisialta nó iad a láimhseáil le bunús pribhléide'.

In éagmais na mbunchearta siúd, tháinig an Ghaeilge slán agus faoi bhláth agus an athbheochan pobal-bhunaithe aitheanta go náisiúnta agus go hidirnáisiúnta. n 2017 tá breis agus 6,000 duine ag fáil oideachais trí Ghaeilge agus tuar ann go mbeidh an dá oiread níos mó ann faoin am seo i gceann seacht mbliana. Gach seachtain, bíonn na mílte duine fásta ag foghaim na teanga ag ranganna ar fud ár gcathracha agus bailte. Ina theannta sin, tá gréasán de choistí, craobhacha agus grúpaí áitiúla teanga i mbun gnímh i bpobail trasna na sé chontae, cuid acu ar na pobail is lú 113 deiseanna sóisialta ó thuaidh.

D'ainneoin pobal na Gaeilge á n-éileamh a gcearta go soiléir glórach, theip ar dheich mbliana den fheidhmeannas comhroinnte cumhachta na cearta siúd a chinntiú dóibh. Tá na cearta seo anois i gcroílár an dioscúrsa pholaitiúil. Tá tacaíocht ag móramh na bpáirtithe agus na feisirí MLA a toghadh le déanaí d'Acht Gaeilge. Shroich ár n-éilimh na Náisiúin Aontaithe mar aon e Comhairle na hEorpa. Tá deis stairiúil ann chun an cheist sheanbhunaithe seo a réiteach agus a chur ina ceart. Cuirfidh tabhairt isteach reachtaíochta ceart-bhunaithe cuí go mór le cneasú agus le hathmhuintearas, agus cuideoidh sé linn sochaí níos tuisceanaí agus ionchuimsithí a chruthú. Chuige sin, d'aithin buaiteoir gradaim Nobel, Seamus Heaney, an Ghaeilge mar ghné bhunúsach riachtanach atá de dhíth chun todhchaí pholaitiúil níos cuimsithí agus níos tuisceanaí a chruthú.

Ní le duine ar bith í an Ghaeilge, is linne ar fad í.

Tá muid ag éileamh go gcuirfí an tAcht seo i bhfeidhm anois chun go ndéanfaí cearta teanga a sholáthar, a chosaint agus a chur chun cinn do phobal reatha na Gaeilge ó achan chearn agus chúlra agus do na glúnta atá le teacht.

Appendix 3: Historical Context

The Irish language has been spoken for more than 2,000 years and is one of the oldest written European languages still in use today. This invaluable heritage has undeniably left a mark on our landscape and culture and on people here. Indeed, just over 150 years ago, Irish was the main language spoken by the majority of people on the island. A fact that isn't widely disseminated is that most of those who died or emigrated during the Great Famine were Irish speakers.

When criticism is made of the politicisation of the language, this shows little regard for or a lack of understanding of the Irish language question – it *is* a political matter. It is not by accident a language revival is needed: the number of speakers has dropped significantly as a result of hostile and aggressive policies against the language over the course of centuries. The implementation of a language act would be a positive move towards addressing historical faults and weaknesses.

The Good Friday Agreement heralded the first positive commitments in regard to the language. The St Andrew's Agreement ensured a language act, similar to the legislation and strategies in the Republic of Ireland and Wales would be passed by Westminster

In the absence of protections written into law, Irish speakers in the north do not enjoy the same rights as Welsh speakers, Scottish Gaelic speakers and other Irish speakers in Ireland. In respect to rights and opportunities 'to learn and use' one's own native language, language expert Fernand de Varennes has said these are basic rights that should not be considered as something to be granted in special cases only or on the basis of privilege.

Despite the absence of these basic rights, Irish has not only survived, but also blossomed, and the community led revival has been recognised on both a national and international level. In 2017, more than 6,000 people are receiving their education through the medium of Irish, and it is predicted this figure will double in the next seven years. Every week, thousands of adults attend classes in cities and towns to learn the language. As well as this, a network of committees, branches and local language groups is active in communities throughout the 6 counties, including in areas that are among the most socially disadvantaged of all.

In spite of the Irish language community's vigorous and clear demands for the fulfillment of their rights, ten years of Executive power sharing has seen a failure in ensuring this has happened. However, such rights are now at the heart of political discourse. The majority of parties and recently elected MLAs supports an Irish language act. Our demands have been noted by the United Nations and the Council of Europe. We now have a unique and historical opportunity to settle this long-running issue. The introduction of suitable rights based legislation will add greatly to healing and reconciliation and will help to create a more understanding and inclusive society. The Nobel Prize winner Séamus Heaney recognised the Irish language as a fundamental and necessary facet of a more inclusive and understanding future for the realm of politics.

No one owns the Irish language; we all own it.

We are calling for the implementation of this act now so that language rights are provided, protected and promoted for the existing Irish language community, no matter where they are and what their background is, and for the generations who will come after us.
